**Why attend:** Among unintentional injuries, drowning is a leading cause of death of children. Almost 800 children fatally drown each year between the ages of 0-17 in the United States. This webinar will highlight three settings in which many drownings occur – in and around the home; swimming pools; and open bodies of water. Age, gender, and race vary considerably according to each of these settings. Prevention strategies for each of these settings will be discussed. Fatality review data has been instrumental in shaping our understanding of fatal drownings.

### **Diane Pilkey, RN, MPH**

Diane Pilkey is a Senior Nurse Consultant at the Maternal and Child Health Bureau/Health Resources and Services Administration and the federal project officer for the National Center for Fatality Review and Prevention cooperative agreement. Diane has more than 20 years of experience in public health at the local, state and federal level, including the Washington State Department of Health, where she worked as an epidemiologist and the Child Death Review Assessment Coordinator. Diane is a registered nurse who has practiced in both clinical and public health settings in both urban and rural settings. Her work has focused on children and adolescents, injury and violence, infant mortality and early childhood. Diane has a Master's in Public Health from the Maternal and Child Health program at the University of Washington Public Health School, a Bachelors in Nursing from the University of North Carolina and a Bachelors in Cultural Anthropology from Duke University

### **Angela Steel, MPHE**

Angela Steel is an Injury Epidemiologist in the Research Department for Safe Kids Worldwide. Before coming to Safe Kids, Angela worked for six years as a pediatric nurse on the Surgical Care Unit at Children's National Medical Center in Washington, D.C. She graduated from The Pennsylvania State University in 2005 with a Bachelor's of Science degree in Nursing and as a 2LT in the United States Army. After working in military and civilian healthcare settings for 10 years, she switched her focus from treating patients to preventing disease and injury. She returned to school at George Washington University in Washington, D.C., where she earned her Master's degree in Public Health Epidemiology.

Tizzy Bennett oversees Community Benefit at Seattle Children's Hospital.
